

Terms and Conditions of the PropTech Festival 2022 popularity contest

1. The Organiser

The PropTech Festival popularity contest is organised by Polskie Towarzystwo Wspierania Przedsiębiorczości SA seated in Katowice and by PTWP-Online Sp. z o.o. seated in Katowice (the latter being the publisher of the PropertyNews.pl, PropertyDesign.pl and Housemarket.pl websites), herein jointly referred to as the Organiser.

2. The purpose of the popularity contest

The PropTech Festival is an event accompanying the **Property Forum 2022**, intended for creators of innovative technologies for the property sector. Creative, innovative, advanced and tailored to the future and market expectations – such are the solutions we want to promote and present to the heads of the largest companies operating in the commercial property market: developers, investors, managers, and tenants.

The PropTech Festival includes meetings, discussions, presentations, and shows. Show your idea

to investors! **For whom?**

We do not create any thematic barriers: Participation in the popularity contest can be declared by both start-ups and experienced companies, such as entities creating innovative solutions applicable in commercial facilities (including office buildings, hotels, shopping centres, shops, warehouses, and public buildings).

What will you gain?

Co-operation and contacts with the heads and representatives of the largest companies operating in the commercial property market in Poland – developers, investors, managers, and tenants. An opportunity to present your solutions during the largest conference for the commercial property market in the region – the Property Forum 2022, as well as promotion on the PropertyNews.pl, PropertyDesign.pl and Housemarket.pl portals and in social media.

3. How do we select the winners?

- Contest entries can only be submitted through the application form. The deadline for submitting contest entries is **30 June 2022**. The contest entry may be accompanied by a maximum of four (4) photos – they should be sent to the following email address: nagrody@propertynews.pl. The size of your email cannot exceed 10 MB. Please specify the name of the popularity contest and the name of your company in the subject line of your email. Sending photos as specified above shall be tantamount to authorising the Organiser of the popularity contest to crop and then publish a given photo in connection with the contest and the title awarded (if any) via websites on the Internet and in the printed press. The party submitting the photos guarantees that it has the rights to grant the above authorisation.
- The Editors of the PropertyNews.pl, PropertyDesign.pl and Housemarket.pl portals, in co-operation with the Jury, shall select 10 of the most interesting contest entries to be announced on the portals **by 11 July 2022**. The next stage shall be the voting of the Readers of the PropertyNews.pl, PropertyDesign.pl and Housemarket.pl portals, which shall last until **31 August 2022**.
- The next stage shall be the presentations of the best solutions – **on 19 September 2022**, during the Property Forum 2022, and the selection of winners (based on the votes of the Jury and the voting on the portals).

- The winners shall be informed about having been awarded prior to the Property Forum 2022 Gala.

4. The Gala

Presentation of the awards shall take place during the official Property Forum 2022 Gala on 19 September 2022.

5. Detailed information on the processing of personal data

1. The controller (joint controllers) of personal data collected during the process of submitting the contest entries is the Organiser. In matters relating to personal data, the Organiser can be contacted at: Plac Sławika i Antalla 1, 40-163 Katowice; odo@ptwp.pl.
2. The personal data collected via the application form shall be processed for the purposes of:
 - a. identifying the contest entry and proceeding with the subsequent stages of the contest, including contacting the applicant and the representatives of the investments entered into the contest, obtaining additional explanatory information concerning the contest entry and the investments entered into the contest, communicating the results of the contest, and arranging for the representatives of the investments to attend the awards ceremony;
 - b. informing about future editions or similar contests, using direct marketing of services, and providing communication between the data controller and the representatives of the investments – in the form of written correspondence, electronic mail, or using telecommunications equipment (phones, SMS).
3. Data processing consisting in the collection, storage and disclosure of data obtained in connection with the contest entry is necessary for the fulfilment of the aforementioned legitimate purposes pursued by the aforementioned controllers.
4. The data shall only be processed for the time necessary to achieve the purposes of the processing, but not longer than until an appropriate objection to the processing is raised or the consent to a given type of processing is withdrawn. It is possible at any time to object to the processing of personal data or to a given type of processing – by sending an email to odo@ptwp.pl.
5. The person whose personal data has been submitted as part of the contest entry shall be entitled to access and rectify their data. The person in question may request the rectification, erasure or restriction of the processing of their data at any time; they shall also have the right to object to a given type of processing and the right to lodge a complaint with the competent supervisory authority, subject to the conditions set out in relevant legislation.
6. In other respects, the rules governing the processing of personal data of entities submitting their contest entries or communicating with the Organiser via the Organiser's portals shall be governed by the provisions of the Privacy Policy of the Organiser's websites, which is available [under this link](#).
