Our selection criteria:

- Applications can be filed via the <u>application form</u>. Deadline for filing applications expires on 20 August 2018.
- A You may attach a maximum 4 photos to your application, sending them to the email address specified below: nagrody@property.pl. The maximum size of an email message may not exceed 10MB. In the title of the email, please enter the name of the competition and the name of the company.
- A Sending photos as above is tantamount to giving authorisation to the Organiser of the Competition to frame and then publish the photos in connection with the Competition and the granted award, if any, via websites and in distributed printed press publications. The entity sending photos guarantees that it is the holder of the right to grant the above authorisation.
- Applications after the initial verification of the editorial office will be sent for the experts' assessment.
- At the same time, the Readers of Propertynews.pl and Propertydesign.pl will participate in voting, which will last until *3 September 2018*.
- The winners will be selected based on the sum of votes (points scored) by the Readers of the Propertynews.pl and Propertydesign.pl, and the Jury members. Votes cast are converted into points. Each expert's vote is converted into 10 points, whereas each vote (click) of an Internet user translates into 1 point.
- Winners are informed about the granted award ahead of the Property Forum 2018.

Detailed information on personal data processing

- The Controllers (Co-controllers) of personal data collected during registration and submission to the competition are: PTWP-ONLINE Sp. z o.o. with its registered office in the City of Katowice as the publisher of the websites and the manager of IT systems used to manage registrations or applications and to support other services provided by the PTWP Group member companies and Polskie Towarzystwo Wspierania Przedsiębiorczości S.A. with its registered office in Katowice, as a parent company in the PTWP Group, Competition organiser, press publisher, event organiser, and provider of other services available via those websites.

- The personal data collected in the application form will be processed for the following purposes:
 - dentify the application form and to proceed with the consecutive Competition phases, including contacting the applicant, the notified entities, and to obtain additional explanatory information about the entry and persons/objects/events notified to participate in the Competition, to inform about the results of the Competition, and to agree on the participation of the participant in the award ceremony.
 - to inform about consecutive editions or similar competitions, to carry out direct marketing of services and to provide communication of data controller with the participant, in the form of written or electronic communication, or using telecommunications devices (telephones, text messages).
- The processing of data consisting in the collection, storage, and sharing of data from the application form is necessary to complete the aforementioned legitimate goals pursued by the aforementioned Controllers. With regard to some data or specific types of processing, which cannot be considered to be required to meet the above-mentioned goals, or in the case of goals that cannot be considered sufficiently substantiated, the Controller may request a separate consent. Then the basis for processing will be an individual consent.
- A The data shall be processed solely for the time required to accomplish the processing purposes, however, not longer than until the time an objection is made to processing or the consent to process the data is withdrawn. You can object to the processing or the type of processing at any time, or withdraw your consents at this link/addressodo@ptwp.pl.
- The person whose personal data has been provided during the application/registration is entitled to access their data and to correct it. Such person may at any time request the rectification, deletion, or restriction of the processing of their data; such person is also entitled to object to specific processing and is entitled to lodge a complaint with a competent supervisory authority pursuant to the terms and conditions set out in relevant legislation.
